- 1) Commissioner Susie Hughes 2425 Safari Lane a) Announced a few upcoming events in the County, b) Community breakfast with her and Supervisor Kieft tomorrow at Mr. B's 8 am, c) Water Policy board meets Wed. Feb 15<sup>th</sup>, at the Water Filtration Plant. It is an open meeting, d) County Committee Meetings were announced.
- 2) Representative Sabo State Rep. for the 92<sup>nd</sup> district. He stated that he or a representative from his office plans to attend our Board meetings. Trustee Ream asked about the Muskegon Heights School issue. Rep. Sabo stated that he is fighting to keep the school open. He emphasized that more time is needed to work on the many challenges that the school has. We need a long term plan. Rep. Sabo also has the support of various groups. He has talked with the School Reform Officer and has questioned their criteria for deciding how to determine when a school should be closed. Trustee Kemp addressed the disabled veteran's exemption, noting that the State could give veterans a deduction by placing it on the MI-1040 instead of a property tax exemption that takes statutory revenue from the local municipalities. Suzie McGee, Dalton Township Deputy Clerk and income tax preparer at Goodwill for veterans and low income people stated, a tax deduction could also be given by the State through homestead property. Representative Sabo also noted the direct correlation between the losses in revenue sharing a municipality has received and the amount of dollars a municipality needs to fund their unfunded actuarial liability insurance for retirees. It was a very interactive and productive discussion with Representative Sabo. 3) Katie Ames– Employee at Muskegon Area District Library (MADL).
