## REGULATIONS FOR USE OF PARKS

- Application for use of pavilion must be made 14 days prior to use, unless under special circumstances.
- The parks and playground of the Township shall be open and available for use between the hours from one-half hour before sunrise until one-half hour after sunset. It shall be illegal for a person to be on the grounds of a park or playground at all other times except as provided in section 34-3 of the Muskegon Charter Township Code of Ordinances.
- Young children must be under the supervision of parents or adult chaperones.
- All equipment used must be left in their proper places.
- The organization/person agrees to be responsible for any accidents or injuries sustained by any person attending or participating in the program or activity for which they may use the park facilities, and to be responsible for replacement in case of any damage or loss incurred in such amount as may be determined by the Muskegon Charter Township Board.
- The organization/person hereby agrees to indemnify and hold harmless Muskegon Charter Township from any liability for damages to any person while on Muskegon Charter Township park premises from any cause whatsoever.
- Park facilities may not be used for private or individual gain.
- Gambling of any kind is prohibited.
- Proper supervision shall be provided by those to whom the accommodations is granted, including police attendance if necessary, to insure the protection of park property.
